6. Option Items

a. The Government may require the delivery of, in whole or part, all Option Items. The Government may exercise an Option Item by written notice to the Contractor. If the Government activates the Option Item, the activation will occur while the Contractor's equipment is in the work vicinity as described in the paragraph of the Dredging Section 02327-3.1.2 entitled "Primary Dredging Region". "Option Dredging" Item work shall be performed as a continuance of "Dredging" Item work, which shall be activated first. "Option Dredge Towing Service" item shall be performed as continuance of "Dredge Towing Service" Item work, which shall be activated first.

b. No additional mobilization/demobilization will be paid to the Contractor for Option Item work performed within the work region. The Contractor shall commence performance of optional work no more than 3 calendar days after the time the Contractor receives the Government's Notice to Proceed with the optional work."
