## SUMMARY OF CHANGES

1. **The required response date has changed from 08-Jun-2007 to 13-Jun-2007 11:00 AM.**
2. 1.3 The Service Contract Act applies to work performed under this contract. The applicable Wage Determination for the West Baton Rouge Parish area is attached.
3. 1.5.1 **Mowing Grounds.** Grass shall be cut on approximately 9.2 acres of improved grounds and are outlined by bold-dashed lines on the grounds maintenance drawing in Appendix B. Grass clippings shall be removed or mulched when visible after mowing. Contractor shall maintain the growth of grass height on grounds between 1.5 to 3 inches. All grounds shall look well manicured at all times. Grass shall be of uniform cut without break, indentation, roughness, or other irregularity. The Contractor is not required to remove weeds. Weeds shall be mowed to the same height as the adjacent grass. Ruts from mowing equipment are unacceptable and covered under the PBWS QASP. Mowing shall be performed according to the frequency required to maintain the grass height between 1.5 to 3 inches. The Contractor is totally responsible for scheduling work as often as required to meet this requirement. Refer to Appendix A.
4. 1.5.7 **Herbicide Application.** Herbicide shall be applied in areas where mechanical methods of plant control are impractical, ineffective, or unsafe. The Contractor shall exercise caution during application so that the herbicides do not injure desirable plants, trees, or shrubbery in the vicinity. All spraying operations shall be coordinated and approved by the LOCK MASTER/TPOC to ensure that non-essential personnel are not present in the area at the time spraying is performed, and that any overspray or windblown chemicals do not pose a hazard to unprotected personnel. Any herbicide used in the control of unwanted vegetation shall contain *GLYPHOSATE* as an active ingredient and shall be recommended for weed control near open waters in accordance with Federal, State, and local requirements. Tank mixture shall be in accordance with label rate for spraying broadleaf-vegetation. Prior to the application of any herbicide, the Contractor shall submit applicable MSDS sheets to the LOCK MASTER/TPOC for approval by the New Orleans District Safety Office.
