The U.S. Embassy, upon receipt of request of shipping documents, shall issue a letter to the Director of Customs certifying that the materials are being brought into **Afghanistan or Tajikistan** ~~Egypt~~ under the applicable agreement and should be allowed into **Country** ~~Egypt~~ duty-free.

Offerors may submit revised cost proposals to the designated POC not later than Monday, 07 February 2005, at 3:00 p.m. local Afghanistan time, acknowledging the amendment and providing any changes in pricing as a result of these clarifications. These revised cost proposals shall remain valid through 30 April 2005.
