Dear Ms. Watson:

HWY 90, LLC is a Type III Construction and Demolition Debris Landfill located at 5000 Highway 90, Avondale Louisiana 70094. The facility is located in Section 9 and 39, Township 13S, Range 22E in Jefferson Parish, Louisiana.

On March 21, 2002 you submitted a report stating that "No known archaeological sites or historic properties will be affected by this undertaking" (see Attachment). During this time HWY 90, LLC was submitting a permit application to the Louisiana Department of Environmental Quality to operate the landfill and the landfill has been in operation since January 2005. Subsequent to the above date, the landfill footprint increased in size and a portion of the undeveloped property on the site will be excavated to provide clay to the U.S. Corps of Engineers (or their contractors) for levee repair and construction. To provide all of the necessary information to the Corps for approval of the material, the Corps is asking for an updated Cultural Resources Report, which will include the expanded boundaries of the property as well as the property boundaries submitted to your office in February, 2002. An updated map is enclosed for your review.

In accordance with LAC Title 33, Part VII, Chapter 521.A.I.e.ii and to provide this information as requested by the Corps, we are requesting that this site and the area within 1000' of the site be reviewed to determine if there are any known archaeological or historic sites or structures located therein.



A Contractor to the Corps of Engineers is currently excavating borrow material from the River Birch borrow pit, located in Jefferson Parish. The borrow area can be viewed on the attached pdf scan, bounded by Live Oak Boulevard on the north and US Highway 90 on the south. These roads and these boundaries can also be seen on the USGS 1:24000 quadrangle Luling and New Orleans West quadrangles.

Through a record search of materials provided by the contractor, CEMVN has found evidence that leads us to believe that SHPO clearance was given to this borrow area in a stamped letter dated March 21, 2002. This letter requested clearance for Section 9 and 39, Township 13S, Range 22E, and is also scanned and attached for your viewing. However, no map of the borrow area requested for clearance by that letter has survived into the modern record. By comparing the Township, Range, and Section given in the letter with the USGS depiction of that location and the T, R, and Section requested in the letter from 2002, CEMVN believes that the current borrow area has received previous SHPO clearance for no impacts to cultural resources.
