You are hereby informed that the contract for the construction of the Napoleon Avenue Phase III, Carondelet Street to Constance Street, Contract W912P8-13-C-0052 Southeast Louisiana (SELA 23a), in Orleans Parish, Louisiana, which is a functional portion of the Southeast Louisiana (SELA) Project, has been completed. The SELA 23a work was completed by the U.S. Army Corps of Engineers pursuant to Section 108 of the Energy and Water Development Appropriations Act of 1996, Public Law (PL) 104-46, Section 533 of the Water Resources Development Act of 1996, PL 104-303, as amended, and the 6<sup>th</sup> Emergency Supplemental Appropriations Act (Chapter 3, Title III), PL 110-252.

A joint agency pre-final inspection of the SELA 23a work was conducted on November 10, 2016. A subsequent joint agency final inspection was conducted on April 4, 2018 and all punch list items were found to have been satisfactorily corrected. All contract work was performed in accordance with the approved plans and specifications, and meets the 10 percent annual exceedance probability design criteria. 



