Dear Messrs. Bradberry and Roberts:

You are hereby informed that the contract for the construction of the Harahan Pump to the River, North Discharge Tubes, Contract Number W912P8-13-C-0017 (SELA 07a), in Jefferson Parish, Louisiana, which is a functional portion of the Southeast Louisiana (SELA) Project, has been completed. The SELA 07a work was completed by the U.S. Army Corps of Engineers pursuant to Section 108 of the Energy and Water Development Appropriations Act of 1996, Public Law (PL) 104-46; Section 533 of the Water Resources Development Act of 1996, PL 104-303, as amended; and the 6th Emergency Supplemental Appropriations Act (Chapter 3, Title III), PL 110-252.

This Notification of Construction Completion (NCC) is for all contractual features associated with the construction contract for the North Discharge Tubes, which can function independently, but does not include the wire pulling through an electrical duct bank and associated electrical work. A subsequent NCC will be issued for these features upon completion of work for these construction items.

A joint agency pre-final inspection of the SELA 07a work was conducted on June 29, 2016. A subsequent joint agency final inspection was conducted on November 15, 2016 and all punch list items were found to have been satisfactorily corrected. All contract work was performed in accordance with the approved plans and specifications, and meets the ten percent annual exceedance probability design criteria. In accordance with the Project Partnership Agreement between the Department of the Army and the Coastal Protection and Restoration Authority of Louisiana, for the Southeast Louisiana, Louisiana Project, Jefferson and Orleans Parishes dated January 16, 2009, the Project Cooperation Agreement between the Department of the Army and Jefferson Parish, Louisiana dated January 16, 1997, and Amendment No. 1 thereto between the Department of the Army and Jefferson Parish, Louisiana dated March 24, 2005, the non-Federal sponsors shall undertake the OMRR&R of this completed project feature of the SELA Project in Jefferson Parish. In this connection, maintenance is construed as keeping all completed works in working condition to serve the purpose for which they were designed. Section 1010 of PL 113-121 provides for an appeals process.
