Check with the Small Business Administration (SBA) to determine whether your business falls within the established table of small business size standards matched to NAICS industries.

You must be registered in SAM.gov to do business with the Federal Government.

Determine if your business qualifies for special certification.

Begin to search for current federal government procurement opportunities.

Familiarize yourself with all acquisition regulations.

Investigate if "getting on the GSA Schedule" is right for you.

Seek additional assistance in the federal, civilian and/or DoD marketplaces. APEX Accelerators are federally funded organizations that offer free help.
