Decision: Request for Final Phase II-Increment 1 Funding Approval for TE-156 Bay Raccourci Marsh Creation and Ridge Restoration (Kevin Roy, FWS). 10:00 a.m. to 10:10 a.m.** At the January 23, 2025, meeting of the Task Force, Phase II-Increment 1 approval was granted to the TE-156 project contingent upon funding availability. Based on the current construction program balance of \$58.5M and the expected return of approximately \$20.9M via first cost reconciliations and project closeouts, FWS and CPRA request final Phase II-Increment 1 approval for TE-156 in the amount of \$36,596,029

Report/Decision: Request to Initiate Deauthorization of the Island Road Marsh Creation and Nourishment Project (TE-117) (Patrick Williams, NOAA) 10:30 a.m. to 10:40 a.m.** Due to changed site conditions, design, constructability, and need for authorization of a change in scope comprised of a funding increase and an acreage decrease, NMFS and CPRA recommend the Technical Committee approve a recommendation to the Task Force to initiate deauthorization of the TE-117 project.
- 7. Decision: FY26 Planning Budget Approval, including the PPL 36 Process, and Presentation of FY26 Outreach Budget (Process, Size, Funding, etc.) (Amanda Landry, USACE) 10:40 a.m. to 10:55 a.m.** The P&E Subcommittee will present their recommended FY26 Planning Program Budget development, including the PPL 36 Process.
- The Technical Committee will vote on a recommendation to the Task Force to approve that the PPL 36 Process include selecting four nominees in the Barataria Basin, four nominees in the Terrebonne Basin; three in the Breton Sound Basin, three in the Pontchartrain Basin; two in the Mermentau Basin, two in the Calcasieu/Sabine Basin, two in the Tech/Vermilion Basin; and one in the Atchafalaya Basin.
 - The Technical Committee will vote on a recommendation to the Task Force to approve the FY26 Outreach Committee Budget, in the amount of \$452,113.
 - The Technical Committee will vote on a recommendation to the Task Force to approve the FY26 Planning Budget (includes Outreach Committee Budget), in the amount of \$5,000,000.

Report/Decision: Selection of Ten Candidate Projects to Evaluate for PPL 35 (Kristen Ramsey, FWS) 10:55 a.m. to 11:25 p.m.** The Technical Committee will consider preliminary costs and benefits of the 35th Priority Project List (PPL) projects. The Technical Committee will select 10 projects as PPL 35 candidates to be evaluated for Phase 0 analysis, which will be considered later for final selection of projects that will be approved for Phase I (Planning and Engineering and Design). A demonstration and/or a coastwide project may or may not be selected to move forward.
