This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. Describe flow regime: During months without a seasonal high water table this drain will have flow in response to precipitation. On average this area experiences 73 days per year with 0.1 inches or more of precipitation. 40 of those days with precipitation occur in months without a seasonal high water table. During months with a seasonal high water table this drain will frequently also have flow inbetween precipitation events from the high water table.

Other information on duration and volume: A seasonal high water table in Calhoun silt loam fluctuates between 2 feet and the soil surface, and in Coteau silt loam from 1.5 to 3 feet deep from December to April. This drain is deep enough to have seasonal flow from that high water table.

Summarize overall biological, chemical and physical functions being performed: Typically unconfined overland sheet flow from the wetland (off-site) abutting the seasonally perennial drain will occur intermittently and in response to rainfall events. Additionally, the wetlands serve as a reservoir during periods of high flow. The wetland is paulustrine forested and part of a riparian corridor up to 200 feet wide. Riparian corridors are known to support reptiles, amphibians, birds and small mammals. The wetlands along this drain have only been lightly managed in the past as part of a forested riparian corridor along a drain. The wetlands abutting the drain help to filter pollutants such as oily residues, pesticides and fertilizers out of runn-off entering the drain. Recent changes in the use of the land suggest that fertilizers and pesticides may be directly applied to the wetland areas during typical lawn maintenance in the future.

**C. SIGNIFICANT NEXUS DETERMINATION**

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**
