This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

These bottomland hardwood wetlands were identified during a site visit by the Corps for a previous jurisdictional determination (MVN-2009-00804-165-SQ) for Buck Carroll Lateral. These bottomland hardwoods were subsequently cleared and the natural drainage features were excavated within wetlands and extended through the adjacent uplands. Although manipulated, the non-RPWs continue to receive flow from the onsite wetlands. Sediment deposition was observed at the interface between the wetlands and non-RPWs as well as within the channel of the non-RPWs. These sediments remain suspended throughout the non-RPW until reaching Buck Carroll Lateral and affect the supply of solutes in the watershed (Alexander 2007). The organic material and aquatic insects in the non-RPW are transported downstream to support the foodwebs of the RPW and TNW (Wipfli 2007). The channelization of these drainage features increased the amount of sediments, organic material, and other suspended solids transported to downstream systems (Brown 1985). In summary the tributary has the ability to affect the biological, chemical, and physical properties of the downstream TNW.
