C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

ADDITIONAL COMMENTS TO SUPPORT JD: This Basis Form documents an RPW (unnamed tributary to Bayou Liberty), its abutting wetlands, an offsite non-RPW (unnamed road side ditch), and its abutting wetlands. The unnamed tributary to Bayou Liberty (RPW) and the wetlands abutting this tributary have a direct hydrological connection to a TNW (Bayou Liberty). Hydrological connections from the wetlands adjacent to the non-RPW are maintained via manmade ditches and culverts. Flow from the wetlands adjacent to the non RPW is to the offsite non-RPW, then W-12 Canal (RPW), then Bayou Liberty (TNW).

B. ADDITIONAL COMMENTS TO SUPPORT JD: This Basis Form documents wetlands adjacent to an RPW (unnamed tributary to Bayou Liberty). These wetlands are directly hydrologically connected to the Rpw via non-jurisdictional swales located north of the project wetlands. During rainfall events, water flows from the adjacent wetlands into the swales, to the unnamed tributary of Bayou Liberty (RPW), and then to Bayou Liberty (TNW).
