This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

- Does the tributary, in combination with its adjacent wetlands (if any), have other relationships to the physical, chemical, or biological integrity of the TNW?

Note: the above list of considerations is not inclusive and other functions observed or known to occur should be documented below:

1. **Significant nexus findings for non-RPW that has no adjacent wetlands and flows directly or indirectly into TNWs.** Explain findings of presence or absence of significant nexus below, based on the tributary itself, then go to Section III.D: A portion of the subject channel is at and below the Ordinary High Water Mark of the receiving RPW and is therefore part of the RPW. Portions of the non-RPW above the OHWM of the RPW will be hydrologically and directly connected to the RPW during periods of flow and/or inundation during periods of high water in Cutoff Bayou. The non-RPW is capable of delivering significant amounts of pollutants directly from the agriculture fields and railroad bed to the RPW and eventually to the TNW (Bayou Folse) downstream. Due to increased flow rates from agriculture and the railroad, the assimilative capacity of the channel is reduced, thereby directly affecting the integrity of the non-RPW, the receiving RPW, and Bayou Folse (RPW-TNW) in a more negative respect. Such high flows are adequate to suspend sediments and other particulates. When inundation is not present, indicators in the non-RPW visible on aerial photography of the project site include sediment deposits and scouring in the tributary, which demonstrate that sediments and pollutants are suspended in the water column at the point where the water enters the RPW. During relatively low flow periods, a portion of sediments and other pollutants will be assimilated by the tributary. During relatively higher flows, a portion of the pollutants will be re-disturbed and additional pollutants will be contributed to the non-RPW and the downstream system. Pollutants in excess of the assimilative capacity of the non-RPW will eventually reach Cutoff Bayou. Likewise, pollutants in excess of the assimilative capacity of Cutoff Bayou will eventually reach the TNW. The tributary in the subject watershed can impact the TNW adversely and beneficially to a lesser degree. To the extent that the tributary can contribute sediments, pollutants, carbon, and floodwater, this system has a significant negative effect on the integrity of the TNW due to reduced system functionality. Thus, the tributary, has a significant nexus with the TNW. The specific beneficial functions accruing in the tributary and associated wetlands include stormwater flow attenuation, short and long-term floodwater storage, nutrient retention and sequestration, sediment retention, and organic matter retention and sequestration, in addition to wildlife habitat. Several of these functions, including nutrient retention and organic matter retention, directly affect the nature of the downstream waters in the Bayou Folse system. It is well established in the scientific literature that upper reach wetlands and waters play a significant role in the characteristics of the downstream waters (see references listed in Section IV. A above). The condition of any RPW or TNW is the sum of the condition of all the inputs from wetlands and tributaries that contribute flow into the RPW or TNW. "Alteration of small streams and wetlands disrupts the quantity and availability of water in a stream and river system." (Meyer et al., 2006).
