Summarize overall biological, chemical and physical functions being performed: This 545 acre drainage area occurs in a watershed of approximately 1080 square miles, and receives an average of 63.71 inches of rain fall that occurs on an average of 71 days with 0.1 inches or more per day. The wetlands in this area provide temporary reservoirs during and immediately after precipitation events, reducing the frequency and extent of downstream flooding. These wetlands occur within pimplemound complexes and along tributaries. In some areas the pimple mound complexes were flattened to make the land suitable for agriculture. This area include open areas with a recent history of agriculture, forested areas, and residential developments. Agricultural areas and residential areas are known to receive direct applications of fertilizers and pesticides. Residential areas include roads and driveways which contribute oily residues to runoff. Forested areas do not experience the same direct applications of pollutants, and where they are downstream from such applications will provide increased filtration. Wetlands such as those found in herbaceous portions of the drainage area support small reptiles, birds and very small mammals, while wetlands such as the forested portions of the drainage area also support larger mammals.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

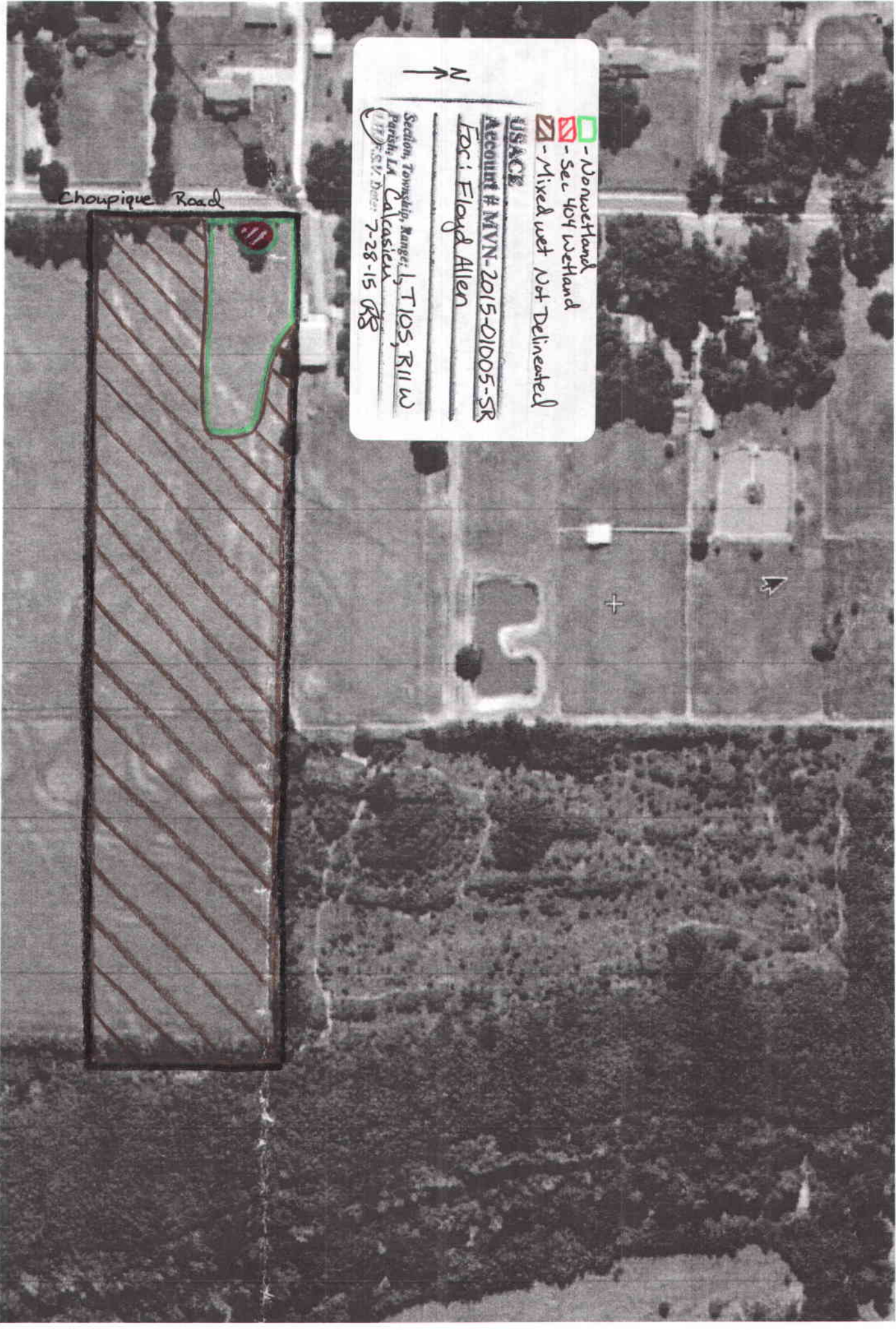
