This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. Summarize overall biological, chemical and physical functions being performed: This area consists of pimple mound topography, with wetlands occurring in an interconnected intermound space. As a result the area contains a series of small wetlands that function together as a part of a matrix. Forested wetlands in this drainage area provide wildlife habitat, and do not receive direct applications of pesticides and fertilizers. Where wetlands in this drainage area occur in maintained residential areas they will receive direct application of pesticides and fertilizers. Where wetlands are adjacent to residential areas and roads, they will receive run off containing oily residues, pesticides and fertilizers. Wetlands such as these help to filter out such pollutants before they flow further downstream. Wetlands such as these are also known to contribute carbon to downstream foodchains. Additionally, the wetlands in this drainage area occur in between scattered mounds. This topography slows the movement of surface water, allowing time for more water to be absorbed into the ground. In turn this contributes to reducing the frequency and severity of downstream flood events.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

- Does the tributary, in combination with its adjacent wetlands (if any), have other relationships to the physical, chemical, or biological integrity of the TNW?


