Dear Mrs. Winter:

This concerns the enclosed communication dated July 1, 2010, relative to your request for acquiring responsibility of an emergency authorization to fill two breaches at Elmer's Island, in order to prevent advancing oil and effects of the MC252 (Deepwater Horizon) spill, from affecting and entering inside bays. Approximately 200-300 sand and concrete bags (8,000lbs) are estimated to fill the breaches using bulldozers and dump trucks. Additionally, you have requested emergency authorization to deposit an additional 5,666 tons of rip-rap, 4,000 cubic yards of sand, and 4,000 linear feet of Geo Tek fabric at the site; all to be located at 29°11'38"N, 90°05'53.9"W, within Caminada Pass, in Grand Isle, Louisiana.

We have reviewed your request and find that the work qualifies under (General Permit) NOD-20 for emergency operations, as long as all conditions of this permit are met. This authorization does not obviate you from acquiring a Louisiana Coastal Use Permit or any other federal, state, or local approvals that may be required by law.

The following conditions are hereby made a part of this emergency authorization:

- 1. The authorized activities shall be done in accordance with your request and performed in a manner that will avoid adverse impacts to the environment and aquatic resources, to the maximum extent practicable.
- 2. Permittee shall monitor the areas where concrete and supplement materials are to be placed, to determine if increased secondary erosion is realized in the area. If increased levels of erosion are recognized, appropriate, environmentally acceptable methods should be taken to stabilize these areas to minimize such impacts. Such monitoring should be done on a regular basis until final recommendations are made through your after-the-fact permit application evaluation.
- 3. Permittee is aware that this office may reevaluate its decision on this permit at any time the circumstances warrant.

- 4. The Chitimacha Tribe of Louisiana has stated that the project area is part of the aboriginal Chitimacha homelands. If during the course of work at the site, prehistoric and/or historic aboriginal cultural materials are discovered, the applicant will contact the Chitimacha Tribe of Louisiana at P.O. Box 661, Charenton, LA 70523, and the Army Corps of Engineers, New Orleans District (CEMVN) Regulatory Branch. CEMVN, Regulatory Branch will initiate the required Federal, State, and Tribal coordination to determine the significance of the cultural materials and the need, if applicable, for additional cultural resource investigations.
- 5. This authorization does not obviate the permittee from obtaining any necessary approvals from other pertinent federal, state, and/or local authorities.
- 6. Mechanized land clearing, filling, or tracking of vegetative wetland areas for access, staging, and/or implementation of the proposed work is not authorized, unless expressly identified on the attached drawings. Any alterations or changes in scope of the proposed project which would have unavoidable impacts to wetland areas not considered under this authorization would require a separate Department of the Army review and decision, prior to commencing that work.
- 7. The permittee shall assure that any contractors, foremen, and/or workers associated with construction of the project are equally aware of the conditions and restrictions associated with this approval.
- 8. If archaeological materials and/or human remains are discovered during ground disturbing activities you shall cease and desist all activities in the project area and contact this office.
- 9. Since this proposed activity occurs within an area impacted by the Deepwater Horizon Oil Spill, the permittee is required to contact the U.S. Coast Guard at (504) 846-5923, prior to commencement of work for the purpose of obtaining clearance to conduct any dredge and/or fill activities within affected areas, as authorized by this permit action.
- 10. Permittee shall have a third party biologist on site to document the presence, or lack thereof, of nesting birds and whether the work results in nest abandonment. On-going coordination shall be maintained with this office, in association with any findings.
- 11. The applicant should take steps to assure that activities associated with the project are done in a manner to maintain aquatic species ingress and egress within shallow open water areas. Encapturing or restraining marine species of interest should be avoided to the greatest extent.
- 12. The permittee shall avoid impacting piping plover habitat and intertidal foraging habitats, further consultation with the USFWS and this office will be required to restore and/or mitigate these effects. The permittee shall have a third party biologist on site to document the presence, or lack thereof, of piping plover and whether the work results in abandonment. On-going coordination shall be maintained with this office, in association with any findings.

- 13. The permittee understands and agrees that, if future operations by the United States require the removal, relocation, or other alteration, of the structure or work herein authorized, or if, in the opinion of the Secretary of the Army or his authorized representative, said structure or work shall cause unreasonable obstruction to the free navigation of the navigable waters, the permittee will be required, upon duenotice from the Corps of Engineers, to remove, relocate, or alter the structural work or obstructions caused thereby, without expense to the United States. No claim shall be made against the United States on account of any such removal or alteration.
- 14. Your use of the permitted activity must not interfere with the public's right to free navigation on all navigable waters of the United States.
- 15. You must install and maintain, at your expense, any safety lights, signs and signals prescribed by the U.S. Coast Guard, through regulations or otherwise, on your authorized facilities.
- 16. If the proposed project, or future maintenance work, involves the use of floating construction equipment (barge mounted cranes, barge mounted pile driving equipment, floating dredge equipment, dredge discharge pipelines, etc.,) in the waterway, you are advised to notify the U.S. Coast Guard so that a Notice to Mariners, if required, may be prepared. Notification, with a copy of your permit approval and drawings, should be mailed to the U.S. Coast Guard, Sector New Orleans Command Center, 201 Hammond Highway, Metairie, Louisiana 70005, about 1 month before you plan to start work. Telephone inquiries can be directed to (504) 846-5923.

This approval is subject to the terms and conditions of (General Permit) NOD-20, dated September 13, 2007, a copy of which is enclosed. Please note that a formal permit application and drawings must be submitted within the time limits stated in the attached general permit.

Your project is located within the Louisiana Coastal Zone, as such your formal permit application submittal must be sent through the Louisiana Department of Natural Resources. Should you require information on submitting your application through their office, please contact Mr. Karl Morgan at

EUA 10-035-1; Emergency Use Authorization (Amended)

Description: Proposed filling of two (2) breaches on Elmer's Island to prevent the advancing oil spill from the BP Horizon from entering the inside bay to protect wildlife. Approximately 200-300 sand and/or concrete bags (8,000 pounds) are estimated to fill the breaches using a bulldozer and dump trucks. Some minimal sand movement may be required to place the sand/concrete bags.

Location: 29° 11' 38" N; 90° 05' 53.9" W.; 29° 11' 38" N; 90° 05' 53.9" W.; Caminada Pass at the Gulf of Mexico;

Jefferson Parish, LA

Amendment: Emergency placement of up to 8,500 tons of rip-rap, 6,000 cubic yards of sand and 6,000 linear feet of Geo-Tek (oil barrier fabric) to elevate (approximately 4') previously installed protective berms.

Amended Location: 29° 12' 16.70" N; 90° 03' 04.30" W (Caminada Pass Start Point; 29° 11' 56.70" N; 90° 03' 03.31" W(Caminada Pass End Point).

We have reviewed the information presented to the Office of Coastal Management (OCM) in your Emergency Use Amended Authorization request dated June 30, 2010. Pursuant to the provisions contained in the LAC (Title 43, Part I, Chapter 7 •723.B.3.), the Emergency Use Amended Authorization request is hereby granted. This Emergency Use Authorization provides only for that work necessary to accomplish the above referenced purpose and is contingent upon acceptance of the following conditions.

- This Emergency Use Authorization is strictly limited to the activity as described in your request and accompanying plats.
- Dredge and fill activities for site access are not authorized unless specifically described in the work statement of this letter.

- 3. The applicant agrees, by virtue of the commencement of authorized activities, to submit to OCM, a complete application packet (\$100 application fee, Joint Application Form, vicinity plats, plan plats, cross section plats, etc.) for the activity not more than thirty (30) days from the date of this authorization. You may obtain a free application packet by calling our office at (225) 342-7591 or (800)-267-4019; or by visiting our website at http://www.dnr.state.la.us/crm/coastmgt/cup/cup.asp.
- 4. The applicant agrees, by virtue of the commencement of authorized activities, to avoid to the maximum extent practicable, vegetated wetland impacts, and if necessary to mitigate for those unavoidable adverse impacts to vegetated wetlands, including submerged aquatics, should OCM determine that mitigation is necessary. Should OCM deem mitigation to be necessary, the applicant agrees, by virtue of the commencement of authorized activities, to submit and fulfill a mitigation plan that has been approved by OCM.
- 5. The applicant agrees, by virtue of the commencement of authorized activities, to adjust, alter, or remove any structure or other evidence of the authorized emergency use if, in the opinion of OCM, it proves to be beyond the scope of the authorized activity or is abandoned.
- 6. The applicant agrees, by virtue of the commencement of authorized activities, to hold and save the State of Louisiana, the Department of Natural Resources (DNR), and their officers and employees harmless from any damage to persons or property which might result from the emergency use.
- 7. The applicant agrees, by virtue of the commencement of authorized activities, to certify that the emergency use has been completed in an acceptable and satisfactory manner and in accordance with the plans and specifications approved by OCM as referenced herein. OCM may, when appropriate, require such certification by given by a registered engineer.
- 8. The applicant agrees, by virtue of the commencement of authorized activities, to ensure that this Emergency Use Authorization, or a copy thereof, shall be available for inspection at the work site at all times during operations.

- 9. The applicant agrees, by virtue of the commencement of authorized activities, to notify OCM of the date on which initiation of the authorized emergency activity began. The applicant shall notify CMD by mailing the enclosed green initiation card on the date of initiation of the authorized activities.
- 10. The applicant agrees, by virtue of the commencement of repair activities, to ensure that the authorized activity does not result in the blockage of any natural or manmade streams or sloughs. A follow-up investigation of the authorized work will be conducted by employees of OCM to determine compliance with this condition.
- 11. The area where the project is located is all part of the aboriginal homelands of the Chitimacha Tribc of Louisiana. As such, large villages, burial sites, and sacred sites were in place in that entire area. If at any time during the course of the work, any traditional cultural properties are discovered, Permittee shall immediately contact Kimberly S. Walden (Cultural Director) or Melanie Aymond (Research Coordinator) at or Common Office hours are Monday through Thursday from 7:30 A.M. 5:00 P.M. and on Friday between 7:30 A.M. 11:30 A.M. If traditional cultural properties are discovered on the weekend or after business hours, the notification shall be made the next business morning.
- 12. The piping plover (Charadrius melodus) may occur within one mile of the project area. This species is federally listed as threatened with its critical habitat designated along the Louisiana coast. Piping plovers winter in Louisiana feeding at intertidal beaches, mudflats, and sand flats with sparse emergent vegetation. Primary threats to this species are destruction and degradation of winter habitat, habitat alteration through shoreline erosion, woody species encroachment of lake shorelines and riverbanks, and human disturbance of foraging birds. No other impacts to rare, threatened or endangered species or critical habitats are anticipated from the proposed project. No state or federal parks, wildlife refuges, wildlife management areas or scenic rivers are known at the specified site or within ¼ mile of the proposed project.

The Louisiana Natural Heritage Program (LNHP) has compiled data on rare, endangered, or otherwise significant plant and animal species, plant communities, and other natural features throughout the State of Louisiana. LNHP reports summarize the existing information known at the time of the request regarding the location in question. LNHP reports should not be considered final statements on the biological elements or areas being considered, nor should they be substituted for onsite surveys required for environmental assessments. If at any time LNHP tracked species are encountered within the project area, please contact our biologist at 225-765-2643.

- 13. Applicant agrees, by virtue of the commencement of repair activities, to notify each oyster lease holder within 1,500 feet affected prior to commencement of the proposed activity.
- 14. All hard structures (including but not limited to sheet pile and riprap) must be marked/lighted in accordance with U. S. Coast Guard regulations. These markers/lights, if required, must be maintained at the site until such time as all potential hazards to navigation are removed. All hard structures shall be removed upon the determination by State and Federal regulatory authorities that there is no longer a significant risk of contamination from the BP Horizion Oil spill to lands in this project area or within two (2) years from the date of this signed authorization, whichever comes first, unless specifically directed to handle otherwise by the ATF permit for this activity.
- 15. Unless otherwise specified, this Emergency Use Authorization will expire 30 days from the date of this letter, if the work has not been initiated or if the applicant has not submitted a complete Coastal Use Permit Application to CMD for the authorized activity. This expiration condition will be waived only if the applicant notifies CMD of the reason(s) for the delay and proposes an acceptable schedule for initiation of the work, or submits a complete Coastal Use Permit Application.





Can you please provide the Corps Number for your referenced EUA 10-036, we believe it may tie into an emergency authorization provided to Lafourche Parish, but it is difficult to determine. 10-035 was the original LDWF gap closure adjacent to Caminada Pass but the EUA numbers mean little to our tracking of these actions and if 036 is in Lafourche another Corps Section probably responded to that action.

The original authorization you reference 10-035 EUA has been past due for the appropriate follow up permit application to maintain the originally placed fill. This is an important issue, it is difficult to consider additional work where appropriate measures are not being taken to keep existing work in compliance. I contacted Christy McDonough about this matter on June 18, 2010 and understand she is working to alleviate oil intrusion, but there needs to be coordination on this follow up action.

Any further information should clearly detail existing conditions at these locations, proposed work (plan and cross sectional views please) the need for the additional work as a response to the immediate oil threat (it has been our understanding through meetings with local officials that the barriers at Caminada are working well) and any other information that will detail your proposal, as discussed in Jay's e-mail this morning.



If traditional cultural properties are discovered on the weekend or after business hours, the notification shall be made the next business morning.
- 12. The piping plover (*Charadrius melodus*) may occur within one mile of the project area. This species is federally listed as threatened with its critical habitat designated along the Louisiana coast. Piping plovers winter in Louisiana feeding at intertidal beaches, mudflats, and sand flats with sparse emergent vegetation. Primary threats to this species are destruction and degradation of winter habitat, habitat alteration through shoreline erosion, woody species encroachment of lake shorelines and riverbanks, and human disturbance of foraging birds. For more information on piping plover critical habitat, visit the U.S. Fish and Wildlife website: http://endangered.fws.gov.

No other impacts to rare, threatened or endangered species or critical habitats are anticipated from the proposed project. No state or federal parks, wildlife refuges, wildlife management areas or scenic rivers are known at the specified site or within ¼ mile of the proposed project.

The Louisiana Natural Heritage Program (LNHP) has compiled data on rare, endangered, or otherwise significant plant and animal species, plant communities, and other natural features throughout the State of Louisiana. LNHP reports summarize the existing information known at the time of the request regarding the location in question. - 14. All hard structures (including but not limited to sheet pile and riprap) must be marked/lighted in accordance with U. S. Coast Guard regulations. These markers/lights, if required, must be maintained at the site until such time as all potential hazards to navigation are removed. All hard structures shall be removed upon the determination by State and Federal regulatory authorities that there is no longer a significant risk of contamination from the BP Horizion Oil spill to lands in this project area or within two (2) years from the date of this signed authorization, whichever comes first, unless specifically directed to handle otherwise by the ATF permit for this activity.




