**CEMVN Issues Notice of Intent in Federal Register for Development of
Environmental Impact Statement on proposed Mid-Breton Sediment Diversion Project**

PERMIT APPLICATION NUMBER: MVN-2018-1120-EOO (Section 10/404)
2019-0104 (Section 408)

APPLICANT: Coastal Protection and Restoration Authority of Louisiana

INTRODUCTION: The Coastal Protection and Restoration Authority of Louisiana (CPRA) has requested permits and permissions from the U.S. Army Corps of Engineers, New Orleans District (CEMVN) to construct, maintain, and operate the proposed Mid-Breton Sediment Diversion Project (proposed Project) on the east bank of the Mississippi River at River Mile 68.6 above "Head of Passes" near Wills Point in Plaquemines Parish, Louisiana. To inform these decisions, CEMVN will prepare an Environmental Impact Statement (EIS) in accordance with the National Environmental Policy Act (NEPA) and has issued a Notice of Intent (NOI) in the Federal Register on July 2, 2020 (<https://www.govinfo.gov/content/pkg/FR-2020-07-02/pdf/2020-14031.pdf>). As part of the preparation of the EIS, NEPA requires an early and open public process for determining the scope of issues, resources, impacts, and alternatives to be addressed by the EIS; commonly referred to as "scoping". CEMVN invites all interested parties to provide input on the proposed Project, alternatives that need to be considered, and potential environmental issues that need to be evaluated in the development of the EIS. The scoping time-frame to provide comments will extend from **July 2, 2020 through August 16, 2020**.

How to Join a Meeting: Participants will be able to join a scoping Webex meeting either by (1) clicking on the “Join Meeting” link located at the top of the project webpage and entering the password provided on that webpage or; (2) calling the phone number and entering the access code identified for each meeting (see above).

Agenda: Each scoping meeting will begin with presentations that have been pre-recorded and are currently available for viewing on the project webpage (see above.) These were conducted in English; but these presentations link to Youtube which allows for English, Vietnamese or Spanish closed-captions. Following the presentations, there will be a Q&A session that lasts for the remainder of the meeting.

Submitting Your Scoping Questions: Questions can be submitted by (1) using the Webex chat box available during the meeting; or (2) submitting from the “Submit Scoping Questions” box located on the project webpage. Interested parties participating by phone only will not be able to use the Webex chat box during the scoping meetings so please submit your questions ahead of time using the “Submit Scoping Questions” box. Participants should be aware that all questions or info submitted from the above process does not serve as your official scoping comments.
